BACKGROUND

In 2013 [Lochailort Investments Ltd](#) submitted an outline planning application to build 49 houses on the green field immediately adjacent to Church mead known as 'Fortescue Fields West'. At the same time they applied to build up to 20 houses on the green field site adjacent to Mackley Lane known as 'Laverton Triangle' or Fortescue Fields East. Both sites are outside the village development limit. An approval to build on these sites, in the context of the recently adopted Mendip Local Plan, could set a precedent for further green field developments in Norton St Philip.

These applications were refused by [Mendip District Council](#) Planning Department in 2014. A few weeks later Lochailort Investments appealed against this decision.

On 3rd & 4th March 2015 at 10am the Government Planning Inspectorate have arranged an 'informal hearing' in Shepton Mallet at which an Inspector will look at evidence presented by Lochailort Investments and Mendip District Council, along with representations from Norton St Philip Parish Council and members of the community. They will evaluate all the evidence against current planning policies and make a final and absolute decision about the future of these two sites.

Lochailort Investments have proposed a number of 'community benefits' along with their planning applications. These benefits were identified using data from the Parish Plan survey in 2005, which is now 10 years out of date. These benefits are what's known as the Section 106 agreement, they are supposed to offset potential 'harm' that would be caused by these two developments.

WHAT YOU CAN DO TO INFLUENCE THE OUTCOME OF THIS APPEAL

We are a group of Norton St Philip residents whose objective is to research some collective views of the community before the Planning Appeal on 3rd & 4th March. We would like to get some up-to-date feedback from you, the residents, about the proposed new houses and the benefits that they potentially bring with them. If we can get enough responses, your 'collective feedback' will be presented by us to the Inspector at that hearing.

Norton St Philip has a village hall known as the 'Palairet Hall' which is 2,100 sq. ft in size. The Palairet Hall is managed and maintained by community volunteers. The Palairet Hall is subsidised each year by a grant from the Parish Council because it is not self-sustaining. The village also has a new cricket pavilion, and space available in the Church, the school and the village pubs. There is surplus capacity at these venues.


